

# COPPABELLA – MOORVALE ONLINE TRAINING COMPETENCY PORTAL UPLOAD GUIDE

Please see the below examples of which certificates are uploaded against the portal "online training codes".

 Please ensure you select all required training on the induction booking forms for the candidate. For example, CHPP Operators who will also be performing electrical work would need to select the CHPP training package as well as the Electrical training package.

If the candidate will be working across multiple sites, it is recommended to complete the portal for the first site and await confirmation back from Pegasus that this has been finalised. Then you will only have to upload any gaps not covered in the first site, into the second site, saving yourself time, and removing duplication of records into the system.

#### QLD OC - Online Training - PEA Core Induction Certificate

- This is core training required to be completed by all coal mine workers, and is recognised at the Burton, Coppabella and Moorvale Mines. Millennium is not a part of this online training platform and will not accept this as evidence for their own induction, as it is not mapped to their procedures.
- These training modules only need to be completed once, and once uploaded in the system, will be automatically recognised across the applicable sites.
